

INTRODUCTION

IG provides investment services and products through the following accounts:

- Contracts for difference ('CFDs') are provided through a CFD Account.
- Spread bets are provided through a Spread Betting Account.
- Options Account are provided through an Options account.
- Turbo warrants are provided through a turbo warrants account.

Spread Bets and CFDs are complex instruments and come with a high risk of losing money rapidly due to leverage.

DIGITAL 100s & SPRINTS

Digital 100s & Sprints are both Binary options. Binary bets are a type of financial spread bet that can be placed through a Spread Betting Account. Binary Options are a type of CFD available on a CFD Account (collectively 'Binaries').

Binaries share many of the same trading risk characteristics as spread bets and CFDs, but due to the different pay out structure there are some different features to be aware of:

- There is no effect of leverage.
- For some types of Binary you will not be able to close the position prior its expiry time.

When trading binaries your capital is at risk. Whilst the amount you can win or lose when trading binaries is fixed there is potential to make substantial losses. This can include losing your entire initial investment.

SECTION 3: OPTIONS (RETAIL CLIENT)

Options are high risk financial products, which are not appropriate for many members of the public.

Options are a type of transaction which gives the buyer of the option the right, but not the obligation, to buy or sell an underlying product at a fixed price at a fixed point in time to or from the writer of the option.

IG will provide European style options which means that they can only be exercised at the point of expiry.

Investing in an option carries a high degree of risk because the structure of the product means that a small change in the price of the underlying market can lead to a proportionally larger move in the price of the option which can work for you as well as against you. CORPORATE EVENTS AND DIVIDENDS

Generally, when determining the bid and offer prices for our options, we will not take into account dividends or other corporate events that may affect the price of the underlying instrument prior to the end of the Expiry Date of the option. Therefore, if a dividend is paid in respect of the financial instrument to which your Option relates (for example, if constituent shares of the underlying index pay dividends), and if your Option is open on the ex-dividend date for the relevant financial instrument, we will make an adjustment to your account on the ex-dividend day to account for this dividend payment.

EUROPEAN OPTIONS

IG offers European options. This means that they can only be exercised at the expiry of the option, rather than at any point during the lifetime of the option. As a result, it is possible that you see a profit when the option is in (or out of) the money when you cannot exercise the option. Market movements may mean that the option then moves against you, causing you to miss out on profits and realise a loss on expiry. You can still close your position prior to expiry to capture profits or avoid a loss.

All options will be cash settled unless otherwise agreed in writing. If you have agreed with IG that settlement and delivery will take place at the expiry of the option, it is your responsibility to ensure that you have the facility to deliver or accept the underlying asset.

FACTORS IN OPTIONS PRICES

There are a number of factors which will have an impact on the price of an option, most notably price and volatility or expected volatility of the underlying market, and time left until the expiry of the option. It is important to be aware of all of these as they will all affect the price of the option. For example, when buying Call Option it is possible for the price of the option to fall even if the price of the underlying increases if the volatility falls and the option expiry date becomes closer as there will be less time value remaining.

Options are a type of transaction which gives the buyer of the option the right, but not the obligation, to buy or sell an underlying product at a fixed price at a fixed point in time to or from the writer of the option.

IG will provide European style options which means that they can only be exercised at the point of expiry.

Investing in an option carries a high degree of risk because the structure of the product means that a small change in the price of the underlying market can lead to a proportionally larger move in the price of the option which can work for you as well as against you. RANGE OF MARKETS

We offer our options across a wide range of underlying markets. Although the prices at which you open Contracts are derived from the underlying market, the characteristics of our Contracts can vary substantially from the actual underlying market or instrument. Full details of all of our Contracts are set out in the Product Details section on our website, including: contract size, last dealing time, settlement procedures, commissions and currency.

CORPORATE EVENTS AND DIVIDENDS

Generally, when determining the bid and offer prices for our options, we will not take into account dividends or other corporate events that may affect the price of the underlying instrument prior to the end of the Expiry Date of the option. Therefore, if a dividend is paid in respect of the financial instrument to which your Option relates (for example, if constituent shares of the underlying index pay dividends), and if your Option is open on the ex-dividend date for the relevant financial instrument, we will make an adjustment to your account on the ex-dividend day to account for this dividend payment.

EUROPEAN OPTIONS

IG offers European options. This means that they can only be exercised at the expiry of the option, rather than at any point during the lifetime of the option. As a result, it is possible that you see a profit when the option is in (or out of) the money when you cannot exercise the option. Types of TWs include Foreign Exchange TWs, Commodities TWs and Stock Index TWs. TWs Long or Short are available for directional investment or hedging solutions.

Investing in a TW carries a high degree of risk because the 'gearing' or 'leverage' so that a relatively small movement in the price of the underlying instrument or asset results in a much larger movement, unfavourable or favourable, in the price of TWs. The price of TWs can therefore be volatile. TWs may expire worthless if the underlying instrument or asset does not perform as expected.. It is possible to lose all of the money invested in a TW.

Any decision to open an account, to buy or sell TWs and to use our services is yours. It is your responsibility to understand the risks involved with TWs.

TURBO WARRANTS – GENERAL RISKS

TWs are intended for retail or professional clients who pursue the disproportionate participation in price changes and / or hedging and have a short-term investment horizon. TW is a financial instrument for clients with informed knowledge and / or experience with leveraged financial products. The client may bear losses up to the total loss of the capital invested and attaches no importance to a capital protection.

TW does not include any protection from future market performance so you could lose some or all of your investment plus any commission or other transaction charges.

CAPITAL RISK

Capital is fully at risk. Clients may lose up to the entire value of their investment;

- if the client sells their TWs prior to the scheduled redemption or exercise date at an amount that is less than the initial purchase price;
- if the TWs are redeemed early for reasons beyond the control of the issuer and the amount paid or delivered is less than the initial purchase price;
- if the strike price of TWs is subject to certain adjustments (notably a daily funding amount) or alternative valuations following certain disruptive market events that result in the amount to be paid or delivered being reduced to an amount or value that is less than the initial purchase price.

KNOCK OUT RISK

If the reference price of the underlying instrument or asset reaches the knock out level, trading in TWs will cease and the TWs become worthless immediately. A client will lose the entire value of its investment in such circumstance.

COUNTERPARTY RISK

Clients face counterparty risk to the TWs issuer in the event of insolvency or bankruptcy proceedings or some other event which negatively affects the issuer's ability to repay amounts due under the TWs. Any failure by the issuer to make payments due under the TWs may result in the loss of all or part of the client investment.

GEARING AND LEVERAGE RISK

TWs are characterised by their leverage effect. The leverage effect (gearing) of TWs, essentially arises out of the considerably smaller amount of capital, as compared to a direct investment in the underlying, that needs to be committed by a client in order to speculate on the price movement of the underlying. This means that a change in the value of the relevant underlying may result in a disproportionate change in the value of the TWs. TWs are associated with a disproportionate risk of loss due to their leverage effect. It can be to the client's advantage in the case of a favourable performance of the underlying but can also be to the client's disadvantage in the case of an unfavourable performance of the underlying.

CURRENCY RISK

If you trade in TWs denominated in a currency other than your TWs Account base currency, you will receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies.

MARKET LIQUIDITY

TWs are authorised for trading on a multilateral trading facility or regulated market. It cannot be guaranteed that such authorisation for trading will prevail for the term of the TWs. In case such authorisation is cancelled it may be very difficult to find market participants who are willing to purchase and sell the TWs. Therefore, it cannot be guaranteed that a liquid market will exist in TWs irrespective of the presence of a market maker. Extraordinary market conditions or markets exhibiting extreme volatility may stop any market making activity. Consequently, a liquid secondary market in TWs may not develop. A liquid secondary market may not prevail for the term of TWs.

GAPPING

Gapping is a sudden shift in the price of an underlying from one level to another. Various factors can lead to gapping (for example, economic events or market announcements) and gapping can occur both when the underlying market is open and when it is closed. When these factors occur when the underlying market is closed, the price of the underlying market when it reopens (and therefore the TW price) can be markedly different from the closing price. In instances of the underlying market gapping, it is likely that there will be gapping in the TWs prices of instruments which derive their value from an underlying market.

Market conditions can change significantly in a very short period of time, so that if you wish to sell an instrument, you may not be able to do so under the same terms as when you purchased it. Under certain trading conditions it may be difficult or impossible to liquidate a position. This may occur, for example, at times of rapid price movement.

OUT-OF-HOURS MARKETS

During the out-of-hours trading sessions of an index or a commodity underlying, no knock out events will occur.

SECTION 6: GENERAL RISKS (APPLICABLE TO ALL ACCOUNTS)

NEED TO MONITOR POSITIONS

It is important that you monitor all of your positions closely. It is your responsibility to monitor your positions and during the period that you have any open Contracts or Transactions, you should always have the ability to access your Accounts.

ELECTRONIC COMMUNICATIONS

We offer you the opportunity to deal and communicate with us via electronic means, for example by our dealing platform and, in certain circumstances, by email. Although electronic communication is often a reliable way to communicate, no electronic communication is entirely reliable or always available. If you choose to deal with us via electronic communication, you should be aware that electronic communications can fail, can be delayed, may not be secure and/or may not reach the intended destination.

OUR SERVICES

Instructions to deal from you to us form a commitment which may only subsequently be revoked by you with our prior consent (such consent will not be unreasonably withheld) at any time before the instruction to deal is executed.

CLEARING HOUSE PROTECTIONS

On many exchanges, the performance of a transaction by us (or third-party with whom we are dealing on your behalf) is 'guaranteed' by the exchange or clearing house and we may have the benefit of certain legal protections from our clearing member. However, it is unlikely that in most circumstances this guarantee or legal protections will cover you, the customer, and may not protect you if we or, another party were to default on obligations owed to you.

INSOLVENCY

The insolvency or default of any other brokers involved with your transaction, may lead to positions being liquidated or closed out without your consent. In certain circumstances, you may not get back the actual assets that you have invested and you may have to accept any available payments in cash. On request, we will provide you with an explanation of the extent to which we will accept liability for any insolvency of, or default by, other firms involved with your transactions.

DEFAULT

In the unlikely event of IG suffering a financial default and not being able to meet its obligations, IG participates in the Securities Trading Companies Compensation Fund (Entschädigungseinrichtung der Wertpapierhandelsunternehmen (EdW), 10865 Berlin/Germany), which covers eligible investments up to 90% of the claim, maximum €20,000 per person, per firm. REGULATORY AND LEGAL RISK

The risk that a change in laws and regulations will materially impact a security and investments in a sector or market. A change in laws or regulations made by the government or a regulatory body can increase the costs of operating a business, reduce the attractiveness of investment and/or change the competitive landscape and as such alter the profit potential of an investment.

This risk is unpredictable and may vary from market to market. In emerging markets such risk may be higher than in more developed markets. For example in emerging markets the inadequacy or absence of regulatory measures can give rise to an increased danger of market manipulation, insider trading or the absence of financial market supervision can affect the enforceability of legal rights.
